

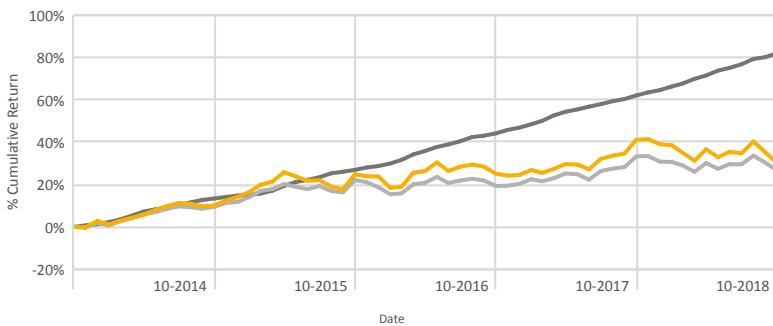
INVESTMENT OBJECTIVE

Investments to be included in the Stringfellow Flexible Fund of Funds may, apart from assets in liquid form, consist solely of participatory interests in portfolios of collective investment schemes investing in equity securities, property shares, property related securities, government bonds, corporate bonds, preference shares, non-equities and money market instruments.

Medium Risk
